## 10. Stability and reactivity

### 10.1. Reactivity

Not reactive under normal conditions of storage and manipulation. Sodium azide has been reported to form lead or copper azide in laboratory plumbing (heavy metals) which may explode on percussion. Treatment of sodium azide with strong acids gives hydrazoic acid, which is also extremely toxic.

### 10.2. Chemical stability

Mixture is chemically stable under normal conditions of storage and manipulation. Overheating may cause thermal decomposition.

### 10.3. Possibility of hazardous reactions

Sodium azide has been reported to form lead or copper azide in laboratory plumbing (heavy metals) which may explode on percussion.

### 10.4. Conditions to avoid

Stable under normal conditions. Keep away from direct sunlight and heat sources. Do not mix with strong acids and heavy metals.

### 10.5. Incompatible materials

Strong acids, heavy metals, halogenated hydrocarbons.
